The meeting commenced with a brief welcome address from Mr. Saif Uddin Ahmed, Procurement Officer (Deputy Secretary), HEQEP. He informed the meeting that the University Grants Commission (UGC) of Bangladesh, under the Ministry of Education is implementing *Higher Education Quality Enhancement Project (HEQEP)* to improve the quality of higher education in the country. The project aims to improve the quality and relevance of the teaching and research environment in higher education institutions through encouraging both innovation and accountability within universities. Raising the connectivity capacity of higher education sector is one major component of the project.

He also added that the main activity under "Raising the Connectivity Capacity" is to establish **BdREN** (Bangladesh Education and Research Network), a high performance information and communications network providing connectivity among higher education and research institutions in both public and private sectors. BdREN will also be connected with other regional and trans-continental Research and Education Networks (RENs) like TEIN 3.
